In compliance of Notification F.No.1-6/LT/2025-INC dated 24.12.2025 issued by Indian Nursing Council, New Delhi

It is for the information of all the eligible candidates desirous for seeking admissions to B.Sc. Nursing, Post Basic B.Sc. Nursing, M.Sc. Nursing, BPT & MPT, and Paramedical Courses in Government/Govt. Aided and Private Institutions affiliated to Pt. BD Sharma UHS Rohtak located in the State of Haryana that the State Government will be conducting Online Combined Centralized Counseling (**Stray Round**) for the Academic Session 2025-26 on the merit of CET-2025 conducted by Pt. BD Sharma UHS, Rohtak for the following courses: –

The detailed process explaining the procedure for admission to the above mentioned courses has been notified by the State Government dated 08.08.2025 and can be downloaded from the Admission Web Portal i.e. <https://uhsrctadmissions.in>, University Website i.e. www.uhsr.ac.in. All the eligible CET-2025 qualified candidates are required to register themselves online through admission web portal. The tentative schedule of Round-3 of counseling is as under:-

Note:-

1. Fresh candidates can register for Stray Round of counseling if not registered in Round-1, 2 & 3.
2. The candidates, who have already registered themselves upto Round-3 and wish to participate in the Stray Round, shall not be required to register again.
3. **The candidates, who have been allotted seats to them in the Round-3 of Counselling, shall not be eligible to participate in the Stray Round/Further round of counselling(if any).**
4. All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Stray Round of counseling and *want to opt for State Quota Seats in only Government Nursing/ Physiotherapy/ Paramedical Colleges shall be required to deposit online Security amount of Rs. 1,000/-* if the candidate wishes to also opt for State Quota Seats and for Management Quota Seats in private Nursing/Physiotherapy/Paramedical Colleges then he/she shall have to deposit online an security amount of Rs. 5,000/-. This facility shall be available in the login ID of the candidates on admission web portal. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Stray Round of counseling. This facility shall be available in the login ID of the candidates on admission web portal.
5. Security amount shall be adjusted in the tuition fee of first year of course, after the candidate joined on the allotted seat.
6. If the candidates are allotted any seat as per their preference in Stray Round, but they do not join on the allotted seat, the **security amount shall be forfeited and these candidates will not be eligible to participate in further round of counselling (if any).**
7. The security amount of the candidates who are not allotted any seat during the Round-2/3 /Stray Round shall be returned after the completion of the counseling process.
8. The candidates, who had deposited security amount in Round-2/Round-3 but not allotted any seat shall not require to deposit security amount again for Stray Round.
9. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the allotted seat shall be cancelled and the security amount shall be forfeited.**

Note: -

- The choices filled by the candidates for the Round-1/Round-2/Round-3 of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Stray Round.
- The above instructions should be read in accordance with Govt. of Haryana notification dated 08.08.2025 and public notices issued from time to time.
- It is informed that aspiring candidates should regularly visit the website of Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak www.uhsr.ac.in, admission web portal i.e. <https://uhsrctadmissions.in> for further details and updates
- **Any admissions made by any private Nursing/Paramedical/Physiotherapy institutes (affiliated to Pt. BD Sharma UHS Rohtak) in the state at its own level shall not be valid and such admission shall be considered as null and void.**
- All candidates should ensure to upload all requisite documents on the Admission Web Portal and complete the registration process as per schedule.
