It is for the information of all the eligible candidates desirous for seeking admissions to B.Sc. Nursing, Post Basic B.Sc. Nursing, M.Sc. Nursing, NPCC, BPT & MPT, and Paramedical Courses in Government/Govt. Aided and Private Institutions affiliated to Pt. BD Sharma UHS Rohtak located in the State of Haryana that the State Government will be conducting Online Combined Centralized Counseling (**Extended Stray Round-II**) for the Academic Session 2025-26 on the merit of CET-2025 conducted by Pt. BD Sharma UHS, Rohtak for the following courses: –

The detailed process explaining the procedure for admission to the above mentioned courses has been notified by the State Government dated 08.08.2025 and can be downloaded from the Admission Web Portal i.e. <https://uhsrcetadmissions.in>, University Website i.e. www.uhsr.ac.in. All the eligible CET-2025 qualified candidates are required to register themselves online through admission web portal. The tentative schedule of Round-3 of counseling is as under:-

Note:-

1. Fresh candidates can register for Extended Stray Round-II of counseling if not registered in Round-1, 2, 3, Stray Round & Extended Stray Round-I.
2. The candidates, who have already registered themselves upto Extended Stray Round-I and wish to participate in the Extended Stray Round-II, shall not be required to register again.
3. The candidates, who have been allotted seats to them in the Round-3, Stray Round, Extended Stray Round-I shall not be eligible to participate in the Extended Stray Round-II.
4. The candidates who have already “joined” on any seat allotted to them upto Extended Stray Round-I, shall not be eligible to participate in the Extended Stray Round-II even after resignation.
5. All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Extended Stray Round-II of counseling and **want to opt for State Quota Seats in only Government Nursing/ Physiotherapy/ Paramedical Colleges shall be required to deposit online Security amount of Rs. 1,000/- if the candidate wishes to also opt for State Quota Seats and for Management Quota Seats in private Nursing/ Physiotherapy/Paramedical Colleges then he/she shall have to deposit online a security amount of Rs. 5,000/-**. This

candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Stray Round of counseling. This facility shall be available in the login ID of the candidates on admission web portal.

6. Security amount shall be adjusted in the tuition fee of first year of course, after the candidate joined on the allotted seat.
7. If the candidates are allotted any seat as per their preference in Extended Stray Round-II, but they do not join on the allotted seat, the **security amount shall be forfeited and these candidates will not be eligible to participate in further round of counselling (if any).**
8. The security amount of the candidates who are not allotted any seat during the Round-2/3/Stray Round/Ext. Stray Round-I/Ext. Stray Round-II shall be returned after the completion of the counseling process.
9. The candidates, who had deposited security amount in Round-2/Round-3/Stray Round/Ext. Stray Round-I but not allotted any seat shall not require to deposit security amount again for Extended Stray Round-II.
10. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the allotted seat shall be cancelled and the security amount shall be forfeited.**

NOTE: For M.Sc. Nursing, Post Basic B.Sc. Nursing courses conditions of Stray Round & for NPCC, conditions of Round -3 will be applicable.

- The choices filled by the candidates for the Round-1/Round-2/Round-3/Stray Round/Ext. Stray Round-I of counseling shall be treated as null and void and the candidates will have to fill fresh choices for Extended Stray Round-II.
- The above instructions should be read in accordance with Govt. of Haryana notification dated 08.08.2025 and public notices issued from time to time.
- It is informed that aspiring candidates should regularly visit the website of Pandit Bhagwat Dayal Sharma University of Health Sciences, Rohtak www.uhsr.ac.in, admission web portal i.e. <https://uhsrcetadmissions.in> for further details and updates
- **Any admissions made by any private Nursing/Paramedical/Physiotherapy institutes (affiliated to Pt. BD Sharma UHS Rohtak) in the state at its own level shall not be valid and such admission shall be considered as null and void.**
- All candidates should ensure to upload all requisite documents on the Admission Web Portal and complete the registration process as per schedule.
