**PUBLIC NOTICE – FINAL ROUND**

As per the instructions issued by Additional Chief Secretary to Govt. of Haryana, Medical Education & Research Department vide Memo No.16/01/2025-6HBIV dated 20.02.2026, it is for the information of all the eligible candidates desirous for seeking admissions to B.Sc. Nursing, Post Basic B.Sc. Nursing, M.Sc. Nursing & NPCC Courses in Government and Private Nursing Institutions affiliated Pt B D S harma UHS, Rohtak located in the State of Haryana that the State Government will be conducting Online Combined Centralized Counseling (**FINAL ROUND**) for the Academic Session 2025-26 on the merit of CET-2025 conducted by Pt. BD Sharma UHS, Rohtak for the following courses: –

The detailed process explaining the procedure for admission to the above mentioned courses has been notified by the State Government dated 08.08.2025 and can be downloaded from the Admission Web Portal i.e. <https://uhsrctadmissions.in>, University Website i.e. [www.uhsr.ac.in](http://www.uhsr.ac.in). All the eligible CET-2025 qualified candidates are required to register themselves online through admission web portal. The tentative schedule of Round-3 of counseling is as under:

**Note:-**

1. Fresh candidates can register for Final Round of counseling, if not registered till now.
2. The candidates, who have already registered themselves upto Extended Stray Round-II and wish to participate in the Final Round, shall not be required to register again.
3. The candidates who have already "joined" on any seat allotted to them upto Extended Stray Round-II, shall not be eligible to participate in the Final Round even after resignation.
4. All candidates (already registered (irrespective of their admission status) and freshly registered candidates) who wish to participate in the Final Round of counseling and *want to opt for State Quota Seats in only Government Nursing Colleges shall be required to deposit online Security amount of Rs. 1,000/- if the candidate wishes to also opt for State Quota Seats and for Management Quota Seats in private Nursing Colleges then he/she shall have to deposit online a security amount of Rs. 5,000/-*. This facility shall be available in the login ID of the candidates on admission web portal. In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the Final Round of counseling.
5. Security amount shall be adjusted in the tuition fee of first year of course, after the candidate joined on the allotted seat.
6. If the candidates are allotted any seat as per their preference in Final Round, but they do not join on the allotted seat, the security amount shall be forfeited and these candidates will not be eligible to participate in further round of counselling (if any).
7. The security amount of the candidates who are not allotted any seat in any round, shall be returned after the completion of the counseling process.
8. The candidates, who had deposited security amount in various Rounds of counselling till now, but not allotted any seat shall not require to deposit security amount again for Final Round.

9. **Grant of one time relaxation to the debarred candidates, who were blocked after 2<sup>nd</sup> Round of Counselling is given to participate in Final Round of Counselling.**
10. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the allotted seat shall be cancelled and the security amount shall be forfeited.**

**NOTE:**

- The choices filled by the candidates till now shall be treated as null and void and the candidates will have to fill fresh choices for Final Round.
- The above instructions should be read in accordance with Govt. of Haryana notification dated 08.08.2025 and public notices issued from time to time.

- **Any admissions made by any private Nursing Institutes (affiliated to Pt. BD Sharma UHS Rohtak) in the state at its own level shall not be valid and such admission shall be considered as null and void.**
- All candidates should ensure to upload all requisite documents on the Admission Web Portal and complete the registration process as per schedule.
