All the eligible CET-2024 qualified candidates are required to register themselves online through admission web portal. Note:-

1. The candidates, who have already registered themselves for the Round-1, Round-2, Round-3, Stray Round, Stray Round-2, Stray Round-3 (Offline) & Special Stray Round (Irregular Batch) and wish to participate in the **SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH)**, shall not be required to register again.
2. The candidates, who have been allotted seats to them in the **Round-3, Stray Round & Stray Round-2, STRAY ROUND-3 (OFFLINE) & Special Stray Round (Irregular Batch)** Counseling shall not be eligible to participate in the **SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH)** round of counseling.
3. The candidates who have already "joined" on any seat allotted to them upto Special Stray Round (Irregular Batch) counseling shall not be eligible to participate in the **SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH)** round of counseling even after resignation.
4. The Candidates shall deposit the provisional tuition fee at the time of physical verification of documents in the shape of **DEMAND DRAFT ONLY** drawn in favour of "**Counseling and admission on A/c for (DMER)**" payable at Sampla, Rohtak before the admission committee on the spot failing which their candidature will not be considered and the seat will be allocated to the next candidate in merit. **Candidates are advised to prepare multiple Demand Drafts.** College wise detail of tuition fee to be deposited on the spot is attached (**Annexure –I**).
5. The personal appearance of the candidates along with all original documents in front of the Admission committee at Pt. Bhagwat Dayal Sharma University of Health Sciences, Rohtak is mandatory failing which his/her candidature will not be considered. Detail of documents to be brought at the time of document verification is attached (**Annexure –II**).
6. All candidates (already registered) and freshly registered candidates} who wish to participate in the **SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH)** counseling and **want to opt for State Quota Seats in only Government Nursing/Physiotherapy/Paramedical Colleges shall be required to deposit online amount of Rs. 1,000/-** if the candidate wishes to also opt for State Quota Seats/Management Quota Seats in private Nursing/Physiotherapy/Paramedical Colleges then he/she shall have to deposit online an amount of Rs. 5,000/-. This facility shall be available in the login ID of the candidates on admission web portal. **In case of failure of any registered candidate to deposit the requisite security amount, they will NOT be considered eligible to participate in the SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH) of counseling.**
7. In case of candidate join on the allotted seat, this security amount shall be adjusted in the tuition fee of the first year of UG/PG Course.
8. **If the candidate found eligible and opt any seat during Physical (offline) allocation of SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH) counseling will be treated as joined on the spot and will have to report and submit their all-original relevant documents on the spot to the representative of the concerned college/institutions.**
9. **If the candidate do not join on the allotted seat, the security amount shall be forfeited.**
10. The security amount of the candidates who are not allotted any seat during the Round 2/Round-3/ Stray Round / Stray Round-2/ STRAY ROUND-3 (OFFLINE) / Special Stray Round (Irregular Batch) shall be returned after the completion of the counseling process.
11. The candidates, who had deposited security amount in Round-2/Round-3/Stray Round /Stray Round-2 / STRAY ROUND-3 (OFFLINE) & Special Stray Round (Irregular Batch) but not allotted any seat shall not deposit security amount for **SPECIAL STRAY ROUND-OFFLINE (IRREGULAR BATCH)**.
12. **In case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled during document verification or fails to produce the required documents at the time of document verification, the security amount fee shall be forfeited.**
13. **As per Govt. of Haryana notification dated 21.06.2024 after exhaustion of merit list of the candidates who have applied under various reserved categories, vacant seats (if any) shall be reverted back to their original category(ies) of seats as per State Reservation Policy and filled up as per merit after conversion (For eg. BC-A seat to BC-B and finally to UR) and filled up in the 3rd round itself for both Government and Private Institutes. However, in case of any seat falling vacant after the 3rd round in any category, it shall first be offered to candidates belonging to original category of vacant seat of the previous round. In case, if the seat still remains vacant, the same shall be filled as per system in the 3rd round and so on".**
